Main Points

a. Attendance and participation

Regular class attendance and participation are <u>required</u>. Attendance and classroom participation are essential for the successful completion of this course. Classroom (chat) discussion is important. It is expected, however, that the discussions will be between a student and the entire class, not just one or two people. Private discussions during chats are distracting to the instructor and class members.

As per PNU attendance policy, a regular student shall attend lectures and practical lessons, and she is prevented from sitting in the final exam if her attendance average is below the one decided by the University Council, i.e, shall not be less than (75%) of lectures and practical lessons determined for each course during the semester. The Student prevented from sitting in the exam because of absence is deemed failed the course and is given grade (DN).

The regular student will be deprived from sitting in the final exam if her absence exceeds 25 % of the total Lectures, practical, and field lessons, and the student deprived of a course is considered failed.

The course instructor gives the student a first warning letter of absence if her absence average exceeds 10% of the total lectures of the course and a second warning letter if her absence 20% reaches 25 %.

b. Grading

PNU has a standard system for assessment grading. A student's grades are calculated against an assessment scale, which is out of 5 points. An assessment receiving F/1.0, i.e. less than 60%, is denoted a failure.





Grades earned by the students are calculated on grade scale basis out of (5) points as follows:

Academic Advising Tasks at the Program level:






Each academic advisor should:
